1. The Government of Nepal [GoN] *has allocated funds* towards the cost of **Construction of Phungling Municipality Office, Phase-III** and intends to apply part of the funds to cover eligible payments under the Contract for **Construction of Phungling Municipality Office, Phase-III, Contract Identification No.: NCB/Phunglingmun/Works/10/076/77**. Bidding is open to all eligible as per Section V of bidding document.
2. **Phungling Municipality, Taplejung** invites electronic bids from eligible bidders for the **construction Works of Phungling Municipality office Building, Phase III** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 4,10,00,000.**
 - Minimum Work experience of similar size and nature: **P.C.C. M20 (1:1.5:3) for R.C.C. Work-156 Cum. & TMT Reinforcement bar (Fe 500) for RCC Works-30 MT.**
 - Bid document fee **NRs. 5,000.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Phungling Municipality, Taplejung, Mob. No: 9841710119, 024-460113, email on the email address info@taplejungmun.gov.np** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 5. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

6. If bidder wishes to submit the Cash Security, the cash should be deposited in the **Phungling Municipality Office Taplejung, Dharauti Account no: 0620300000003000001** Dharauti at **Nepal Bank Limited, Taplejung** branch and submit the receipt of the deposited amount of cash along with the bid.
7. Pre-bid meeting shall be held at **Phungling Municipality Office, Taplejung** at Time: **13:00, Date:2076/10/19(2 February 2020)**.
8. Electronic bids must be submitted to the office **Phungling Municipality Office, Taplejung** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 PM** on **2076/10/29(12 February 2020)**. Bids received after this deadline will be rejected.
9. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM** on **2076/10/29(12 February 2020)** at the office of **Phungling Municipality Office, Taplejung**. Bids must be valid for a period of **90days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 10,00,000**, which shall be valid for 30 days beyond the validity period of the bid.
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
