5. Bids must be submitted through e-GP system <https://www.bolpatra.gov.np/egp> on before 12:00 Hrs on 05 Ashad 2076 (20 June 2019). Bids received after this deadline will be rejected.
6. Bids must be valid for a period of 90 days after opening of bids and must be accompanied by Cash Security or Bank Guarantee, amounting as mentioned in table below, which shall be valid for 120 days after opening of the bids.
7. If bidder wishes to submit the Cash Security, the cash should be deposited in the **Phungling Municipality Office Taplejung, Dharauti Account no: 062030000000300001 Dharauti at Nepal Bank Limited, Taplejung branch** and submit the receipt of the deposited amount of cash along with the bid.

Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format.
